The PNP CES-BAC shall hold a Pre-Bid Conference on **May 8, 2017 at 10:00AM (Monday)** at the CES Social Hall which shall be open to all interested parties who purchased the Bidding Documents.

The bidders shall drop simultaneously their duly accomplished eligibility/technical and financial components in two (2) separate sealed envelopes in the bid box provided for at the CES Social Hall, Ground Floor Commel Building, PNP, Camp Crame, Quezon City on or before **May 22, 2017 (2:00PM, Monday)**.

In view of the effectivity of the 2016 Revised Implementing Rules and Regulations (RIRR) issued by the Government Procurement and Policy Board (GPPB) and the forthcoming issuance by the GPPB of a new and official Public Bidding Documents template, all words, phrases, clauses, and provisions in this Bidding Documents are understood to be read and interpreted in accordance and in conjunction with the 2016 RIRR. In case of conflict between this Bidding Documents and the 2016 RIRR, the latter shall prevail. All bidders are presumed to have been apprised of the provisions of the 2016 RIRR.
