KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT made in the 9th day of January 2017 between **COMMUNICATIONS AND ELECTRONICS SERVICE**, a National Support Unit of the PNP created and existing by virtue of and pursuant to Section 35 (a) (3), RA 6975, its principal office address located at Camp Crame, Quezon City, hereinafter called the "ENTITY" of the one part and **R.G.P. Enterprises of 152-C Scout Gandia, Brgy. Sacred Heart, Quezon City** hereinafter called the "SUPPLIER" of the other part:

WHEREAS the Entity invited the submission of Price Quotation for the **Procurement of CCTV System for SOSIA-FEO One-Stop-Shop Building in Camp Crame, Quezon City** and has accepted the Proposal by the Supplier for the items in the sum of **Eight Hundred Seven Thousand One Hundred Pesos only (P807,100.00)** (hereinafter called the "Contract Price") broken down as follows:

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

3. The Entity hereby covenants to pay the Supplier in consideration of the provision of the items and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


